REGULAR MEETING OF THE BREWSTER COUNTY COMMISSIONERS COURT TUESDAY, JULY 26, 2016, AT 9:00 A.M.

The Judge Cano called the meeting to order and the following Elected Officials were present:

1. Invocation, Pledge of Allegiance

Judge Cano led the Court in an Invocation and the Pledge of Allegiance.

2. Public Comment

No public comment at this time.

3. Minutes / additions / corrections / approval

Minutes for June 14, 2016 and June 28, 2016 were presented for approval. Commissioner Garrett suggested minor changes to June 28, 2016 minutes.

Commissioner Garrett moved to approve the minutes for June 14, 2016. Commissioner Ortega seconded the motion and the motion passed unanimously.

June 28, 2016 minutes will be tabled until Judge Cano can clarify a statement where Big Bend Telephone item is made clear.

4. Road & Bridge Department / Community Facilities

A. Road & Bridge Superintendent's Report, General updates on maintenance and repairs for all county roads & state of County Roads System; road materials including, fuel, supplies including usage & inventories & future needs; budgetary matters; equipment including heavy equipment, (maintenance repairs, future needs, replacement and additions), pickups, trailers and other light vehicles and accessories, and small equipment, (usage, future needs), equipment rentals; facilities (yards in Alpine, Marathon and S. County) cattle guards, fences and other means of containing livestock; safety issues and equipment; and community facilities (assistance with maintenance and other

related issues); assistance to other governmental entities and emergency responders; personnel issues, (vacancies, new hires, discipline, performance, safety and other general personnel matters); permits for boring or trenching for utilities across County Roads / Discussion and appropriate action

Commissioner Ortega reported for Superintendent Causey.

Commissioner Ortega stated that Superintendent Causey and some of his crew were working on the remainder of Mile High Road. Commissioner Ortega reported that the busses for AISD were delivered to Van Horn and the dump truck was picked up from El Paso and Midland. A new water pump was put into one of the pick-ups. Road& Bridge finished Wagon Rd, mowed and cleaned up Pena Park and removed the stucco from the walls on District Courtroom, reported Commissioner Ortega.

B. Discussion and appropriate action for general work of Road & Bridge Department to go forward

Discussion of new equipment took place. Commissioner Ortega stated the he had bids through by-board and could get prices by Thursday to review and look into purchasing procedures

5. County Emergency Management Office

A. General Report including:

Recent emergency responses; emergency planning update; recent work with cooperating emergency responders: (ESD #1, all VFD's and EMS); update on needs, programs, training, recent work with other governmental entities; equipment for emergency response and updates regarding needs, maintenance, repairs, replacement and additions; emergency management issues related to burn bans; emergency management issues related to communications & public information; emergency management issues related to County insurance coverage; personnel issues related to emergency response, exercises & drills; matters related to pending & future Homeland Security & FEMA Grants and other funding, matters related to 911 EMS in County and matters related to 911 & 911 addressing / Discussion and appropriate action

Emergency Manager Matt Van Ostrand reported the he received the remaining information for the Environmental Assessment for the radio maintenance contract. All proper paperwork was sent off and once complete the Sheriff's Office will have \$10,000 for radio repairs. Van Ostrand talked to several Emergency personnel in the area and he recommended a burn ban be put in place.

Commissioner Ortega moved to approve the burn ban restrictions. Commissioner Pallanez seconded the motion and the motion passed unanimously.

Commissioner Ortega brought up closing in the bays at the Marathon Fire Department and thinks Brewster County Crew could do it for about \$10,000 to \$12,000 in materials.

B. Discussion and appropriate action for general administrative work of the Emergency Management Department to go forward

Nothing further to discuss.

6. Treasurer's Office

A. General Bills / Discussion and appropriate action

Treasurer Mann reported that the general bills total \$176,632.80. Walk—Ins total \$63,240.08 for a grand total of general bills to total \$239,872.88. Treasurer Mann explained an invoice from The Bank of New York Melon. Treasurer Mann explained the I&S fund was short and suggested a line item transfer. The difference is \$25,437.54 informed Treasurer Mann. Auditor Watson suggested a line item transfer from general to I&S to cover the \$25,437.54 short fall.

Commissioner Ortega moved to approve a line item transfer of \$25,437.54 from General Fund to I&S. Commissioner Novovitch seconded the motion and the motion passed unanimously.

Commissioner Pallanez provided information about the trash bin located at the Tax Office and the number of pick-ups vs the cost. Commissioner Pallanez stated that currently the County pays for a 4 cubic bin with 3 pick-ups and cost the County about \$10,000 a year. He proposed to get a 3 cubic foot container with one pick-up a week which will cost about \$100.00 a month. Treasurer Mann stated that she also spoke with the City Office and it can be done with a letter stating that the Court approved the change.

Commissioner Pallanez motioned to change from a 4 cubic foot container to a 3 cubic foot container with one pick-up a week instead of 3 pick-ups. Commissioner Ortega seconded the motion and the motion passed unanimously.

Commissioner Ortega moved to approve the walk-in and the general bills as presented. Commissioner Novovitch seconded the motion and the motion passed unanimously.

Treasurer Mann reported there were a few bills that came in that needed to be paid. This fell between Commissioner Court Meetings, explained Treasurer Mann, and asked to approve these bills.

Commissioner Ortega moved to approve the bills as presented. Commissioner Novovitch seconded the motion and the motion passed unanimously.

Commissioner Ortega moved to amend the budget as presented. Commissioner Pallanez seconded the motion and the motion passed unanimously.

 - A. Discuss & consider variance request from the Brewster County Subdivision Regulations by Johnny Carpenter

B. Revision of Existing Boundaries concerning Private Property and County Roads specifically located in the Cul De Sac of Sunny Glenn/ Discussion and appropriate action

Commissioner Novovitch explained on this property the carport of the homeowner is in the County Road easement. A revision of the boundaries will eliminate the issue, explained Judge Cano.

Commissioner Novovitch moved to approve a new survey, changing the easement on Cul De Sac of Sunny Glenn. Commissioner Pallanez seconded the motion and the motion passed unanimously.
