## REGULAR MEETING OF THE BREWSTER COUNTY COMMISSIONERS COURT TUESDAY, OCTOBER 26, 2010, AT 10:00 A.M.

Judge Beard called this meeting to order. Officers present are listed as follows:

To discuss and take action as appropriate on the following:

#### 1. Minutes / additions / corrections / approval

The minutes from the October 11, 2010, meeting were presented for approval.

Commissioner Ortega made a motion to approve the minutes, which was seconded by Commissioner Stone, and passed unanimously.

#### 2. Treasurer

#### A. General Bills

Treasurer Ofenstein noted an \$5,325 payment for furniture for the Marathon Justice Center. There was also a \$197,000 payment from Stonegarden for CopSync.

Commissioner Ortega made a motion to approve the general bills and the infrastructure bills as presented, which was seconded by Commissioner Stone, and passed unanimously.

Commissioner Killingsworth abstained from 68450 and 68451.

Two walk-in bills were presented; the first was a reimbursement of \$134.96 to Commissioner Stone for his hotel room for the Far West Texas Commissioners and Judges conference; the second was for a \$5,000 down payment to Roberts Mechanical.

Commissioner Killingsworth made a motion to approve the walk-in bills, which was seconded by Commissioner Ortega, and passed unanimously.

#### B. Infrastructure Projects Bills / Discussion and appropriate action

Her office has received a \$70,327 reimbursement for the library building, and has billed the ESD for \$26,901 for furniture. Brewster County will cover the remaining \$19,000.

### C. Indigent Defense Grant Resolution / Discussion and appropriate action

Treasurer Ofenstein said they receive about \$9,000 annually from the State. Commissioner Ortega made a motion to approve the resolution, which was seconded by Commissioner Killingsworth, and passed unanimously.

No reports were presented for approval.

#### 4. Road & Bridge Department / Community Facilities

A. General updates on maintenance and repairs for all county roads; road materials including, fuel, supplies including usage & inventories & future needs; equipment including heavy equipment, (maintenance repairs, future needs, replacement and additions), pickups, trailers and other light vehicles and accessories, and small equipment, (usage, future needs), equipment rentals; facilities (yards in Alpine, Marathon and S. County) and community facilities (assistance with maintenance and other related issues); assistance to other governmental entities and emergency responders; personnel issues, (vacancies, new hires, performance and safety); permits for boring or trenching for utilities across County Roads

Supt. Frenchie Causey said they finished the pads in front of the doors at the Alpine Fire Department. They have a little more to do to complete the fencing at the site.

They finished cleaning up the CASI site, and are hauling those materials up to the Water Tank site to use for road fill.

Some crews moved to Marathon and have hauled away some trash from the Justice Center and brought in dirt. They installed the gutters and have been doing some painting. A stop sign was installed in Sunny Glen.

Mr. Causey watched while Old Marathon Hwy. was bored under to make sure it was done correctly.

#### B. TxDot Border Colonia Access Paving Grant

Engineer Travis Roberts said the contract was awarded at the last meeting to Jarratt Dirt Work. The contractor should bring the contracts back to the Judge's office soon.

Mr. Roberts said they'll probably be ready to start the second week in November.

He is going to review the placement of the waterlines in Study Butte next week.

Commissioner Killingsworth asked about the easements. Mr. Roberts said they are working on four different documents, and he'll probably have them ready in the next couple of weeks.

Commissioner Ortega said the signage has been installed.

2. Alpine VFD Fire Station & Emergency Operations Center / Update on final matters necessary to complete and close out Project / Discussion and appropriate action to close project

Judge Beard said the chain-link fence which has been installed was recycled. It was there when the property was purchased. The crew moved it before construction began, and it now has been installed along the U.P. right-of-way and west boundary of the property.

Commissioner Killingsworth said they have a few things to wrap up, and they are on the final punch list.

#### 7. U.S. / Mexico Border Counties Coalition / Update

Judge Beard said Brewster County has been a part of this organization for the last few years. It is a group comprised of Border counties across the U.S. border with Mexico. It's primary purpose is to lobby Congress for the special needs of border counties.

The State Criminal Assistance Program (SCAP) was discussed. SCAP provides reimbursement for costs incurred by counties when illegal aliens are charged and prosecuted. It was noted on the Border Prosecution Initiative that there is a presidential initiative to do away with the program. Judge Beard suspects that doing away with that Initiative may have something to do with publicity in Arizona and Texas.

## B. 2009/2010 Texas Department of Rural Affairs Community Grant Program (Study Butte Water Tank Project)

Mr. Roberts said a pre-construction meeting is scheduled for Nov. 1. After that, they intend to issue a Notice to Proceed. The tank contractor in Austin is working on assembling all the parts.

The money for the Terlingua Springs waterline is included in this grant. Commissioner Killingsworth said that part of the reason they had to wait on this project is because they were waiting on approval for the waterline.

Mr. Roberts said they could start construction in March. During construction, the old line will be kept in service while each individual line is transferred onto the new line. The old like will then be "killed off."

### 9. I.T. Department Report and Update

# A. Infrastructure Projects / installation & wiring for computers / Networking and related issues

Commissioner Killingsworth said the ports are wired in on the South County project. They still finish out three or four.

IT Director Leo Ofenstein said they are working on connectivity from the buildings to the Sheriff's Office. He said the telephone coverage drops from time to time, but he doesn't expect is to be a large problem because usage is not large-scale.

Commissioner Killingsworth asked if the server will reboot itself if the power goes out. Mr. Ofenstein said it would.

Commissioner Ortega said he needs to get the order in for the phone lines in Marathon.

### B. Networking / Jail and Law Enforcement Update

Mr. Ofenstein said the jail's system has been installed. They are waiting on the Sheriff's Office to get it finished on their side.

# C. County Road Map Project / Discussion and appropriate action to commence work on Digitizing Road Map

Mr. Ofenstein said County maps are available on demand with a day or two of lead time. They are able to access data from the Federal and State governments, and 911 data. They can get aerial photos from the COG, although they have to be "stitched" together.

Judge Beard said there is a large need for a map of just County Roads. It doesn't need to include any other data, only the County Roads.

Mr. Ofenstein said the data is available; he needs a specific definition, and it can be done in a few days. Judge Beard said she will work on that definition.

Mr. Ofenstein said it can be placed on the website.

Judge Beard asked Mr. Of enstein to work with Frenchie Causey on the Road map.

## D. Discussion concerning development of schedule for replacement of County owned hardware / (No action)

Commissioner Killingsworth said developing a schedule would help with budgetary needs, as would knowing in detail all that the County actually owns in the way of hardware.

She asked Mr. Ofenstein to begin developing a plan, and he said he would. Commissioner Killingsworth asked Mr. Ofenstein if he has any concerns or anything to add.

He said he has a pretty good idea of what the County has and what it needs. He said he would contact the Department Heads to talk about what they have and what their needs are.

## 10. Announce November 2010 Meeting Schedule / Discussion and appropriate action

Due to the holiday schedule, Judge Beard is proposing one November meeting on Monday, Nov. 15. The last day available for canvassing the General Election is also Nov. 15, so the Canvass would also be held on Nov. 15.

Commissioner agreed that the schedule would work as proposed by Judge Beard.

Commissioner Killingsworth made a motion to authorize the Treasurer to pay all the standard, recurring bills in the month of November. Commissioner Ortega seconded the motion, which passed unanimously. (See agenda item 2D.)

Judge Beard recognized Commissioner Pallanez for h is work on the COG's Solid Waste Advisory Committee.

Judge Beard noted that the County and City worked together in 2005 for the first Dump Day. It was not grant-funded. Commissioner Ortega noted a large clean-up effort in Marathon as well. Ongoing efforts for community cleanups were noted, up through 2009, including placement of roll-off containers.

In 2006, a Dump Day was held for Terlingua Ranch, and twice for South County, Alpine and Marathon. The effort continued in 2008, and grant funding in the amount of \$18,300 is forthcoming for additional clean-up efforts, including placement of roll-off containers in Alpine, Marathon, and at the South County yard. Commissioner Killingsworth mentioned the metal recycling program which the County conducted several years back. Judge Beard mentioned that the County R&B Crew had recently taken loads of tires for recycling.
