Commissioner Ortega made a motion to approve the minutes, which was seconded by Commissioner Stone and passed unanimously.

Commissioner Ortega made a motion to accept the general bills, which was seconded by Commissioner Killingsworth, and passed unanimously.

Commissioner Killingsworth abstained from 72887.

Treasurer Ofenstein presented two walk-in bills, the first for \$98 for a printer cartridge for her printer, and the second for \$65 to Nectar Computers.

Commissioner Killingsworth made a motion to approve the walk-in bills, which was seconded by Commissioner Ortega, and passed unanimously.

- A. Colonia Construction Fund Application / (2nd Septic Tank Replacement Grant Application for S. Brewster County)
 - 1. Update on Project & Application Process

Grant Administrator Jerry Carvajal said 24 septic tanks had been completed as of July 7. He said there are seven applicants for Phase 2 at this time. Commissioner Killingsworth said she has some additional applications and would like to go ahead and approve some of them at the next meeting as the December deadline is approaching.

Judge Beard said she feels like we are asking for a lot of extensions, and would like to get out of that pattern.

Mr. Carvajal said he is waiting on some signatures from TDRA to finish out Phase 1.

Commissioner Killingsworth asked if, in the future, it will take about 30-60 days to get final completion clearance from the state. Mr. Carvajal said it will.

Judge Beard suggested a workshop for everybody to go over the process so that it moves more quickly.

Mr. Carvajal said the completion paperwork, including payment for the engineer, has been submitted to TDRA. A final inspection of the tank is expected today. When that is done, the engineer will submit completion documents to Mr. Carvajal, and those will be processed by the State.

Commissioner Killingsworth and Judge Beard talked about the long wait for small businesses to be paid by the state. If there is a way to speed up the process, it needs to be done.

Documentation for transfer of ownership needs to be completed quickly and efficiently as well.
