## 4. Recognitions

A. Recognize Big Bend Livestock Show Association, 4-H, F.F.A., and Texas Agri-life Extension Service for show held on January 12<sup>th</sup>, 13<sup>th</sup>, & 14<sup>th</sup>

Logan Boswell, Agri-Life Extension Agent reported to the Court that the final figures for the stock show were not complete but the auction brought in more than \$250,000, he also stated that was not a record but close.

B. Recognize Logan Boswell upon his retirement from the Texas Agri-Life Extension Service / Resolution in Honor of Logan Boswell upon his retirement

Commissioner Ortega moved to accept a Resolution regarding Logan Boswell for his decades of service to the community. Commissioner Esparza seconded the motion, and the motion passed unanimously.

County) cattle guards, fences and other means of containing livestock; safety issues and equipment; and community facilities (assistance with maintenance and other related issues); assistance to other governmental entities and emergency responders; personnel issues, (vacancies, new hires, discipline, performance, safety and other general personnel matters); permits for boring or trenching for utilities across County Roads / Discussion and appropriate action

Road and Bridge Superintendent Frenchie Causey reported to the court that his crew has been very busy, trimming trees, checking EMC generators and finishing windows in the District Courtroom.

Judge Cano asked Commissioners to be on the lookout in their precincts for road related maintenance projects that needed attention.

## 8. Brewster County Auditor

County Auditor Treva Watson presented the 2015 Jail Inmate Fund Audit, After discussion, Commissioner Ortega moved to approve the 2015 Jail Inmate Fund Audit. Commissioner Pallanez seconded the motion; motion passed unanimously.

A. Brewster County Policy Handbook/Revision of Section 2A-Employee Payroll Reflecting Commissioners Court Approval (November 22nd, 2016) to change from 24 Pay Periods to 26 Pay Periods/Discussion and appropriate action

Discussion was held on the Policy Handbook about revising Section 2A-Employee Payroll to reflect Commissioners Court approval on November 22<sup>nd</sup>, 2016 to change from 24 pay periods to 26 pay periods. Brewster County Tax Assessor/Collector Betty Jo Rooney discontinued passport services for the County effective January 12, 2017. Judge Cano told the Court he had received less than a week's notice of the termination, and expressed concern over the lack of notice given. Commissioner Ortega stated that the Court should have been notified that this was coming.

Judge Cano called for a recess at 10:19 a.m. and reconvened at open session at 10:35 a.m.

After discussion on the AVFD ladder Truck, Commissioner Ortega moved to give authorization for vehicle to be towed by Alpine Wrecker Service for evaluation by Permian Fleet Services in Odessa, Tx. Commissioner Garrett seconded the motion; the motion passed unanimously.

After a brief discussion from Chief Deputy Ryan Skelton. Commissioner Ortega moved to approve 2018 Justice Assistance Grant Program Operation Border Star Application and Resolution. Commissioner Esparza seconded the motion; and passed unanimously.

B. Tri County Juvenile Probation/Request to Approve 2018 Juvenile Justice Grant Program Application and Resolution/Discussion and appropriate action

Erica Blecha with the Tri County Juvenile Probation office presented a request to approve 2018 Juvenile Justice Grant Program application and Resolution. Commissioner Ortega moved to approve the 2018 Juvenile Justice Grant. Commissioner Esparza seconded the motion, and passed unanimously.

- 14. Brewster County Tourism Council
  - A. Budget Amendment for Courthouse Restoration Project / Discussion and appropriate action

Robert Alvarez requested a budget amendment for the Courthouse restoration project in the amount of \$25,000.00. He stated these funds were actually reallocated from last years budget of the funds not used for restoration. Commissioner Ortega moved to approve the budget amendment and Commissioner Esparza seconded the motion, and passed unanimously.

B. Budget Amendment to increase Tourism Budget for 2017 / Discussion and appropriate action

After a brief discussion on the Tourism Budget for 2017, Commissioner Esparza moved to approve a budget amendment of \$20,075.00, seconded by Commissioner Ortega, and passed unanimously.

C. Discussion on future funding needs for courthouse restoration

Robert Alvarez spoke to their attorneys and informed that the furnishings for the courtroom do not fall under historic restoration preservation.

Commissioner Pallanez questioned why Terlingua and Marathon cleaning do not make the same amount? Commissioner Ortega stated that the post park is added to their duties.

Commissioner Ortega moved to accept the bid for purchase of property held in trust by Alpine I.S.D. Commissioner Esparza seconded the motion; the motion passed unanimously.
