This proposed budget will raise more total property taxes than last year's budget by \$619,023.18, (8.0%), and of that amount, \$30,613.54 is tax revenue to be raised from new property added to the tax roll this year.

A Public Hearing on the Proposed 2020 Budget will be held on August 16, 2019, & (August 21st, 2019, if needed) at 9:00 A.M. in the Brewster County Courthouse, Commissioners Courtroom, Alpine, Texas. Any member of the public may appear and comment at that hearing.

This budget is based on the best available data from the Brewster County Tax Office, CAD, and Auditor's & Treasurer's Office, at the time of preparation.
