Commissioner Ortega moved that the property tax rate for debt service be set at 0.02591. Commissioner Pallanez seconded the motion; motion passed by vote 5-0.

3. Total Rate Proposed 0.421531

Commissioner Ortega moved that the property tax rate be increased by the adoption of a tax rate of \$0.421531, which is effectively a 14.17% increase in the tax rate. Commissioner Pallanez seconded the motion; motion passed by vote 5-0.
